

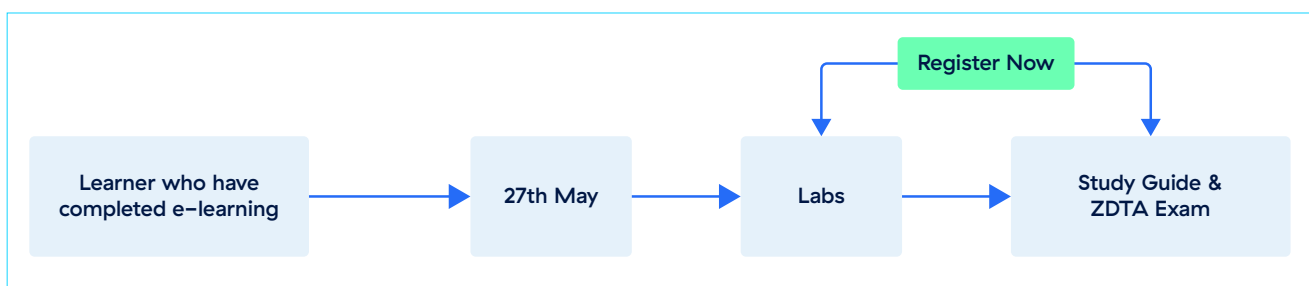
# Zscaler for Users– Essentials Learning Path Refresh Policy

We're excited to announce a refresh of our Zscaler for Users – Essentials (EDU-200) Learning Path! This update will ensure you have the latest knowledge and skills on Zscaler's Zero Trust Exchange platform. This document outlines instructions for all learners taking the Zscaler for Users– Essentials course and the impact it would have on their current learning journeys.

Please follow the instructions below as they apply to your current learning journey for the EDU-200 Learning Path completion.

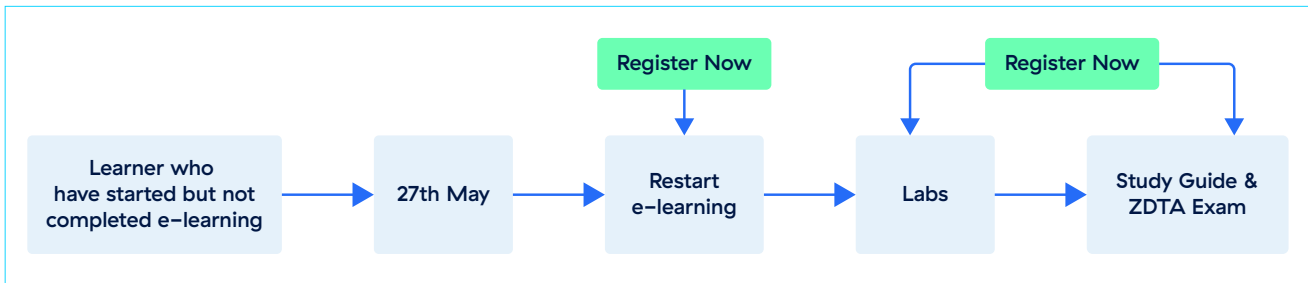
## Scenario 1: Zscaler for Users – Essentials (EDU-200) e-learning completed

This path applies to those who have already completed the e-learning but are yet to take labs and the exam. Once we launch the newly refreshed elearning courses, and the learning path on 27th May, 2024, you can register for labs. Once you have completed the labs, you can take the certification exam. You do not have to take the elearning courses again. This refresh does not significantly impact your existing knowledge of Zscaler's core functionalities. It includes updated capabilities, environment familiarity, and some new features. If you want to explore the new content, you can always come back later to take the refreshed course.



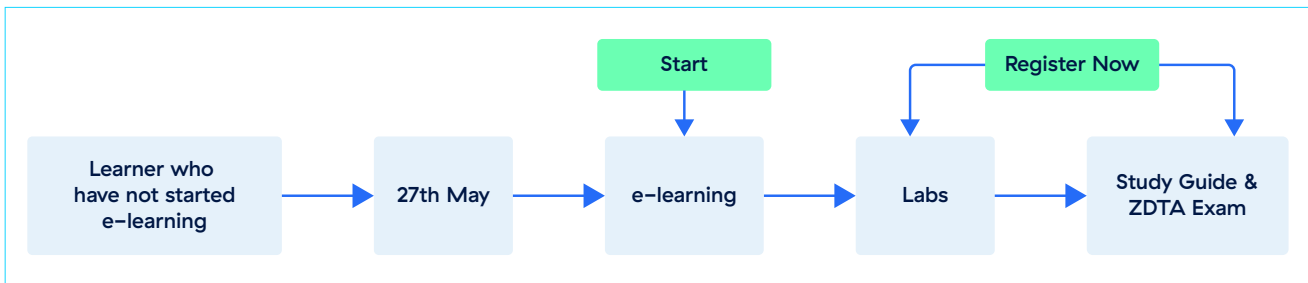
## Scenario 2: Zscaler for Users– Essentials e-learning in progress/mid-flight

This path applies to those who have started but are yet to complete e-learning and take labs and the exam. Once we launch the refreshed e-learning course on 27th May, 2024, you will need to restart the e-learning in the refreshed learning path, as you will lose your progress. After completing the e-learning, you can take the labs followed by the certification exam. Keep in mind that the seat time for the new refreshed courses are shorter than the existing courses.



### Scenario 3: Zscaler for Users- Essentials e-learning not started

This path applies to those who are yet to start e-learning and take labs and the exam. Once we launch the newly refreshed e-learning courses, and the learning path on 27th May, 2024. You can start your e-learning in the refreshed learning path and after completing the e-learning you can register for the labs and then take the certification exam.
